1 Introduction

1.1 About

The biblatex-ext bundle provides an extended version of the standard styles that come with biblatex. For each standard style this bundle provides a style with the same name prefixed with ext- which can be used as a drop-in replacement for the standard style – for example, the replacement for authoryear-icomp is called `ext-authoryear-icomp`.

The aim of the styles of this bundle is to offer a simple interface to change some of the stylistic decisions made for the standard styles that would otherwise need cumbersome and tedious redefinitions. Additionally, some customisation features that were not deemed appropriate for inclusion in the biblatex kernel are provided. Other than that the styles are

as close to the standard styles as possible. They do not attempt to offer options or commands for customisations that are already fairly simple to achieve with the tools provided by the standard styles.¹

The initial motivation for this bundle was what has now become the option `inname-beforetitle`. It is fairly straightforward to print the name of the editor of an `@incollection` before the `booktitle`. But if one does not want to resort to clever tricks,² the modifications needed to do this in a stable, safe and clean manner by redefining the bibliography drivers can easily amass hundred lines of code – code you may not want to see in your preamble. Some contributed `biblatex` styles already place the editor in the desired position, but you may not want to commit to the other changes implied by switching to one of those styles. Especially styles written for the sole purpose of implementing the requirements of a particular style guide may have to go to great lengths to do so and are therefore not as easily modified as the standard styles. The styles of this bundle, on the other hand, try to stay as close to the standard styles as possible both in output and implementation to allow you to customise the styles with minimum additional effort over the standard styles.

A few words of warning: The styles of this bundle are only really useful if you want to use one of their features to avoid having to go through the lengthy and tedious redefinitions the standard styles would require. Before you get involved in modifying the standard styles or one of the styles of this bundle, you may want to have a look at the host of other styles available for `biblatex`,³ maybe you are lucky and the style you are looking for has already been implemented by someone else. As was the intention, most methods to modify the standard styles are also applicable to the styles of this bundle, but you may break some of their features if you happen to modify something that the `ext-` styles redefine themselves. While many contributed `biblatex` styles are examples of good `biblatex` style coding, this cannot be said of all of the files included in this bundle. Especially the citation styles for compact citations have to work harder to implement the citation delimiter feature properly. So if you want to get inspired for your `biblatex` coding, be warned that terrible things lurk in the `.cbx` files. The standard `.cbx` files will give you a much better impression of how things should be done.

1.2 Requirements

The use of the styles requires a current version of the `biblatex` package. At the time of writing the latest version of `biblatex` is 3.20 (dated 2024-03-21), that version is required for the styles to work properly. A warning will be issued if you use an older version. You may choose to ignore that warning, but the styles cannot be guaranteed to work properly in that case: you might get other warnings or errors, and some features of the style might just fail silently.

Use of the Biber backend is strongly encouraged. Most of the new features of this bundle do not require Biber explicitly in their implementation, but many `biblatex` standard features only work properly with Biber.

1.3 Compatibility with earlier versions

In an ideal world all changes to the styles in this bundle would be fully backwards compatible. Unfortunately we do not live in this ideal world. Most changes to this bundle should introduce new features that have little relevant impact on existing functionality. But the occasional change may have more lasting consequences and may cause existing customisations to fail. In fact all changes have the potential to break someone's code, since `biblatex` styles have little to no distinction between public and internal code. Still, some changes are more likely to be problematic than others and those should be kept to a minimum. They can, however, be required to move development forward.

If possible, backwards compatibility measures that allow old code to continue to work are in place. Sometimes that is not feasible and in those cases the next best solution is to warn if old code is used, so please check the log file for warnings – especially after an update. But at times not even that is possible, so it is always a good idea to consult the change history after an update and to examine the output with extra scrutiny. Higher-level changes are found in the revision history in section 8, more technical changes and commentary can be found in `CHANGES.md`, the full set of changes can be investigated by comparing the tagged and publicly available source code.

1.4 Installation

This style bundle is available on CTAN.⁴ The current release is also available in MikTeX and TeX live 2018 or newer. If at all possible you should install this bundle via your TeX distribution (using MikTeX Console⁵ or `tlmgr` for TeX live⁶). If you must install this package manually, get the files from CTAN and install the `.bbx`, `.cbx`, `.def`, `.sty` and `.lua` files preferably to `tex/latex/biblatex-ext` of your local or home TeX tree⁷, the other files (`CHANGES.md`, `README.md`, `biblatex-ext.tex`, `biblatex-ext.pdf` and `biblatex-ext-examples.bib`) go into `doc/latex/biblatex-ext`. You may have to refresh your file name database afterwards, so TeX can find the files.

2 Use

The `biblatex-ext` bundle is a collection of `biblatex` style files. You can load the styles exactly as you would load the standard styles:

```
\usepackage[style=<style>]{biblatex}
```

The naming of the styles follows the scheme `ext-⟨standard style⟩`, e.g., the style corresponding to `authoryear-icomp` is called `ext-authoryear-icomp`.

This manual assumes familiarity with the concepts of `biblatex` and does not attempt to explain any of the standard `biblatex` features, so you may want to have the `biblatex` documentation¹² at hand to fully appreciate what is going on. If you are new to `biblatex` the three hundred odd pages of the manual can be hard to stomach at first, so you may want to have a look at a more gentle introduction. Of the many introductory texts and tutorials available on the internet¹³ the author particularly likes Knut Hegna and Dag Langmyhr's *Local Guide to biblatex*¹⁴ and Paul Stanley's *biblatex – An Easier Read*¹⁵. French speakers may want to consider Maïeul Rouquette's *(Xe)L_AT_EX Appliqué aux sciences humaines* available on CTAN¹⁶. If you read German you may be interested in Dominik Waßenhoven's two-part series *Bibliographien erstellen mit biblatex* in *Die T_EXnische Komödie* 2/2008¹⁷ (pp. 53–75) and 4/2008¹⁸ (pp. 31–51). Please keep in mind that some of these texts were written a while ago and that `biblatex` is actively developed: technical details may have changed and new features make some things easier.

3 Styles

This bundle provides an extended version of each standard style as well as a few new styles.

3.1 Standard styles

Please refer to the `biblatex` documentation¹⁹ and the style examples²⁰ for a more detailed description of each standard style. The relations between the styles are exactly as in their standard counterparts. The `ext-` styles only build on top of the standard files.

`ext-numeric` An extended version of the standard numeric style for citations with numeric labels.

```
\usepackage[style=ext-numeric]{biblatex}

`ext-numeric-comp` An extended version of the standard `numeric-comp` style. Similar to `ext-numeric`, but citation labels are compressed to give ‘[1–3]’ instead of ‘[1, 2, 3]’.

`ext-numeric-verb` An extended version of the standard `numeric-verb` style. This style is similar to the `numeric` style, but each citation label is in its own set of brackets: ‘[1], [2], [3]’.

`ext-alphabetic` An extended version of the standard alphabetic style for citations with alphabetic labels derived from author name and year.

`ext-alphabetic-verb` An extended version of the standard `alphabetic-verb` style. This style is based on `ext-alphabetic`, but like `ext-numeric-verb` places each citation label in its own pair of brackets: ‘[SR98], [Knu86c]’.

ext-authoryear An extended version of the standard authoryear style for citations using author name and year.

ext-authoryear-comp An extended version of the standard authoryear-comp style. The style is based on the author-year citations of ext-authoryear, but several works by the same author are compressed by not displaying the author multiple times: ‘Knuth 1984, 1986’ instead of ‘Knuth 1984; Knuth 1986’.

ext-authoryear-ibid An extended version of the standard authoryear-ibid style. This style is similar to ext-authoryear, but repeated citations are replaced with ‘ibidem’.

ext-authoryear-icom An extended version of the standard authoryear-icom style. This style combines the two styles ext-authoryear-comp and ext-authoryear-ibid.

ext-authortitle An extended version of the standard authortitle style for citations by author and title.

ext-authortitle-comp An extended version of the standard `authortitle-comp` style. This style is based on `ext-authortitle` and compresses several citations by the same author just like `ext-author-year-comp`: ‘Aristotle, *Physics, Poetics*’ instead of ‘Aristotle, *Physics*; Aristotle, *Poetics*’.

ext-authortitle-ibid An extended version of the standard `authortitle-ibid` style. This style is similar to `ext-authortitle`, but replaces repeated citations of the same work with ‘*ibidem*’.

ext-authortitle-icom An extended version of the standard `authortitle-icom` style. This style combines `ext-authortitle-comp` and `ext-authortitle-ibid`.

Aristotle, *Physics, Poetics* Maron, *Animal Triste* *ibid.*

ext-authortitle-terse An extended version of the standard `authortitle-terse` style. This style is similar to `ext-authortitle`, but the title is omitted in citations if there is only one work by the relevant author.

ext-authortitle-tcomp An extended version of the standard `authortitle-tcomp` style. This style combines `ext-authortitle-terse` and `ext-authortitle-comp`.

ext-authortitle-ticom An extended version of the standard `authortitle-ticom` style. This style combines `ext-authortitle-terse`, `ext-authortitle-comp` and `ext-authortitle-ibid`.

Aristotle, *Physics, Poetics* Sigfridsson and Ryde *ibid.*

ext-verbose An extended version of the standard verbose style. This style shows the full bibliographic reference the first time a work is cited.

ext-verbose-ibid An extended version of the standard verbose-ibid style. Based on ext-verbose, repeated citations to the same work are replaced with ‘ibidem’.

ext-verbose-note An extended version of the standard verbose-note style. Based on ext-verbose and intended for use in footnotes, subsequent citations link back to the footnote the entry was cited at first and in full.

ext-verbose-inote An extended version of the standard verbose-inote style. Similar to verbose-note, but repeated citations to the same work are replaced with ‘ibidem’.

ext-verbose-trad1 An extended version of the standard verbose-trad1 style. This style makes extensive use of scholarly abbreviations and is otherwise similar to ext-verbose.

ext-verbose-trad2 An extended version of the standard verbose-trad2 style. The style is similar to ext-verbose-inote and uses scholarly abbreviations to shorten citations.

ext-verbose-trad3 An extended version of the standard verbose-trad3 style. This style is similar to ext-verbose-trad2.

3.2 New styles

The following styles are not mere extensions of a particular standard style, instead they implement new combinations or extensions of the concepts available in the standard styles.

ext-authoryear-ecomp An author-year citation that is even more compact than ext-authoryear-comp, it compresses lists of extradate letters from ‘Knuth 1986a,b,c’ to ‘Knuth 1986a–c’.

ext-authoryear-iecomp An author-year citation that is even more compact than ext-authoryear-icom, it compresses lists of extradate letters from ‘Knuth 1986a,b,c’ to ‘Knuth 1986a–c’.

ext-authoryear-terse An author-year citation style that suppresses years for author lists with only one work in the bibliography. This style is like `ext-authortitle-terse`, but it is based on `ext-authoryear` and not on `ext-authortitle`.

Sigfridsson and Ryde Knuth 1984 Knuth 1986

ext-authoryear-tcomp A compact author-year citation style that suppresses years for author lists with only one work in the bibliography. This style is like `ext-authortitle-tcomp`, but it is based on `ext-authoryear` and not on `ext-authortitle`.

ext-authoryear-ticomp A compact author-year citation style with ‘*ibidem*’ function that suppresses years for author lists with only one work in the bibliography. This style is like `ext-authortitle-ticomp`, but it is based on `ext-authoryear` and not on `ext-authortitle`.

ext-authoryear-tiecomp A compact author-year citation style that combines `ext-authoryear-ticomp` and `ext-authoryear-iecomp`.

ext-authornumber An author-number citation style. The number is taken from the `extraname` field which increases separately for each labelname list.

ext-authnumber-comp A more compact version of `ext-authnumber` that prints the author only once if subsequent references in the same citation share the same author. This style will print ‘Knuth [1, 2]’ instead of `ext-authnumber`’s ‘Knuth [1]; Knuth [2]’. The style will enable the `sortcites` option.

ext-authnumber-ecomp An even more compact version of `ext-authnumber-comp` that also compresses the citation numbers if appropriate. ‘Knuth [1–3]’ instead of `ext-authnumber-comp`’s ‘Knuth [1, 2, 3]’.

ext-authnumber-terse A version of `ext-authnumber` which drops the number if there is only one work by that author.

ext-authnumber-tcomp A combination of `ext-authnumber-terse` and `ext-authnumber-comp`.

ext-authnumber-tecomp A combination of `ext-authnumber-terse` and `ext-authnumber-ecomp`.

4 Options

All options of the biblatex package are supported and each style supports the options of its standard counterpart.

4.1 General options

Additionally, all styles support the following options in global, per-type and per-entry scope. The default values are such that the styles can be used as drop-in replacement for the standard files without significant changes in output.

`articlein=true, false`

default: true

Whether or not to display ‘in:’ before the journal information in @article entries. All other entry types are not affected by this option. If it is desired to remove the ‘in:’ for more entry types or a more specific behaviour is required, then it is still going to be necessary to modify the bibmacro in:.

`citexref=true, false`

default: false

This option controls if @inbook, @incollection and @inproceedings entries that are tied to a parent entry with xref or crossref show all data of their parent entry inline as usual or if they cite their parent entry instead *if* the parent is listed in the bibliography as a separate entry. With the default setting citexref=false the parent is not cited, the entry is shown as in the standard styles. If the option is set to true, the block following the ‘in:’ with the parent data is replaced by a citation to the parent entry and thus becomes more compact.

Parent entries will only be cited by this feature if they appear in the bibliography.

The option itself does *not* cause the parent entry to be added to the bibliography automatically. This needs to happen either explicitly by citing the parent (possibly with `\nocite`) or implicitly via the `minxrefs` or `mincrossrefs` option.

For technical reasons the citation label is not produced with a real `cite` command. The user-definable parts of the citation output are controlled by the bibmacro `bbx:xrefcite`.

`bbx:xrefcite` This bibmacro typesets the ‘citation’ to the parent entry. With many citation styles it will just call the `cite` bibmacro, but in more complex styles it may also call additional initialisation or clean-up code.

In order to reproduce the citation label accurately in the bibliography, some initialisation and housekeeping needs to be done.

`\AtXrefcite{⟨code⟩}`

`\AtXrefcite*{⟨code⟩}`

Appends the `⟨code⟩` to an internal hook executed when initializing `\xrefcite`. The starred variant of the command clears the initialisation hook, so the defaults can be overwritten. The default settings execute the internal macro `\extblx@bibcite@init`, which makes sure that the output takes into account the citation settings but suppresses unwanted citation tracking and hyperlinks.

Even though the citation produced by this option is not implemented via a citation command, the output can be configured as if it were produced by a citation command called `\bbx:xrefcite`, which by default is set up to inherit most styling from `\cite`.

4.2 Style-specific options

`dashed=true, false, fullhash, bibnamehash`

default: true

The dashed option of the `authoryear-`, `authortitle-` and `ext-authornumber-` like bibliography styles allows for finer control over the dashes than in the standard styles. The option is available globally and additionally on a per-type and per-entry level.

This option controls whether or not recurring lists of authors/editors in the bibliography are replaced with a dash. The standard values `true` and `false` are still valid and give the exact same output as in the standard styles. This means that the output is fully compatible with the standard styles. The new values `fullhash` and `bibnamehash` differ in how exactly they determine if a list of authors/editors is the same as the previous.

`true` An alias for `fullhash`.

`false` Disable this feature.

`bibnamehash` Replace recurring name lists with a dash. Compare name lists using `bibnamehash`, taking into account only names that are actually listed in the bibliography account.

`fullhash` Replace recurring name lists with a dash. Compare name lists using `fullhash`, taking into account all names in the list, even those that are truncated and do not appear in the bibliography.

Assuming `maxnames=1` and no name list disambiguation (`uniqueList=false`), the four entries

With dashed=bibnamehash the dash replaces the name list if they are indistinguishable in the bibliography, while with dashed=fullhash the lists are only replaced if they are indistinguishable in the data source.

`introcite=false, plain, label`

The `introcite` option is available for the bibliography styles of the `authoryear`, `authortitle` and `ext-authornumber` family. It cannot be used with citation styles of the `verbose` family, where it may produce undesired output or errors.

The option is available globally and on the per-type and per-entry levels. The value `label` needs support by the bibliography environment. It is therefore only available globally out of the box. A warning will be issued if `label` is used on an unsupported level. The values `plain` and `false` are supported on all levels.



This option controls whether or not the citation label is repeated in the bibliography. There are two possible output formats.

- `false` Do not show the citation label in the bibliography.
- `plain` Show the citation label at the beginning of an entry.
- `label` Show the citation label as the label of a list similar to the `numeric` or `alphanumeric` styles.

The difference between `plain` and `label` is that the former simply prints the citation label at the beginning of the entry, while the latter prints the citation label similar to the item labels in a list or the numeric labels in a `numeric` bibliography.

Note that the implementation of some related types automatically suppresses the `introcite` label – or rather, does not add the label in the first place. That means that the resulting bibliography should be checked for consistency if the toggle is set to `true`.

The `label` option can be configured to not allow the label to run into the remaining bibliography entry thus creating the appearance of a tabular-like bibliography. The citation label is not broken across lines, instead it moves the entry text into the next line with `\introcitebreak` if the width of the citation is greater than `\introcitewidth`.

- `\introcitewidth` The maximum width of the citation label. The initial value is 8 times `\biblabelsep`.
- `\introcitesep` This length sets the minimal space between the end of the citation label and the beginning of the rest of the entry. The initial value is `\biblabelsep`.
- `\introcitebreak` The command to execute if a citation label exceeds `\introcitewidth`. The default is `\leavevmode\newline`.

In order to reproduce the citation label accurately in the bibliography, some initialisation and housekeeping needs to be done.

Appends the `<code>` to an internal hook executed when initializing `\introcite`. The starred variant of the command clears the initialisation hook, so the defaults can be overwritten. The default settings execute the internal macro `\extblx@bibcite@init`, which makes sure that the output takes into account the citation settings but suppresses unwanted citation tracking and hyperlinks.

The appearance of the citation label can be customised mostly as if it were produced by a true citation command called `\bbx@introcite`. The delimiter context is `bbx@introcite`, the inner citation delimiters can be accessed as `bbx@introcite` as well. The label does not have outer citation delimiters, you can use the wrapper field format `bbx@introcite` instead. In fact this approach is more versatile than the outer citation delimiter feature (see the discussion in section 5.3). The default settings for `\bbx@introcite` emulate the output of `\cite`.

5 Further Customisations

Aside from the new options mentioned in the last section the styles of this bundle also offer additional field formats, punctuation and delimiter commands, a new citation delimiter interface and a few new bibliography macros.

The citation delimiter interface is a novel feature of `biblatex-ext`, but for the other subsections familiarity with the underlying `biblatex` concepts is assumed. Some of this is easier understood by looking at the source code directly, so it might not be a bad idea to have `ext-standard.bbx` open when perusing this section of the manual.

5.1 Field formats

The styles of this bundle offer customisable field formats in a few places where the standard styles employ hard-coded formatting directives instead. Field formats can be modified with `\DeclareFieldFormat`.

bibextraname The format for the number added to the name in `ext-authornumber`-like styles. The default is to wrap the number in square brackets.

Finer control over the title casing of each field could require involved code.²¹ The field format `titlecase:title` is applied to the fields `title` and `subtitle`. By default this field format is an alias for `titlecase`.

`titlecase:booktitle` Like `titlecase:title`, but controls the title casing of the `booktitle` and `booksubtitle` fields.

`titlecase:maintitle` Like `titlecase:title`, but controls the title casing of the `maintitle` and `mainsubtitle` fields.

`titlecase:journaltitle` Like `titlecase:title`, but controls the title casing of the `journaltitle` and `journalsubtitle` fields.

`titlecase:issuetitle` Like `titlecase:title`, but controls the title casing of the `issuetitle` and `issuesubtitle` fields.

`titlecase:biblabetitle` Like `titlecase:title`, but controls the title casing of the title printed instead of missing author/editor name in authoryear styles.

The `citetitle` field format can be used to change the title case in author-title citations, so there is no `citetitle:labeltitle`.

5.2 Punctuation

The package provides the following commands to modify the delimiters and punctuation between fields. Normal punctuation commands should be redefined with `\renewcommand`, while context-sensitive commands marked with `context sensitive` should be redefined with `\DeclareDelimFormat`. A short overview over common punctuation commands defined by `biblatex-ext` as well as standard `biblatex` in an example bibliography can be found in section A.

`\namenumberdelim` Similar to `\nametitledelim`, but for the punctuation between the name and the label number in `ext-authornumber` styles. The default is a space. context sensitive

5.3 Delimiters for citation commands

The delimiters for citation commands provided by the styles of this bundle offer a simple way to customise the bracketing of citation commands.

The citation commands `\cite`, `\parencite` and `\textcite` come with two sets of delimiters: A pair of *outer delimiters* wrapped around the resulting citation in its entirety and a pair of *inner delimiters* that sets off certain bits of the citation label from other information. An example for outer delimiters would be the round brackets of `\parencite` for `authoryear`-like styles or the square brackets of `\cite` for `numeric`- or `alphabetic`-like styles. Inner delimiters would be the round brackets in `\textcite` around the year for `authoryear` or around the title for `authortitle`. See table 1 for more details.

The delimiters are set up to work as paired delimiters, but you are free to use non-matching pairs or to leave the opening or closing delimiter empty. If you want to add punctuation, the context-sensitive delimiters `nameyeardelim`, `nametitledelim`, `postnotedelim` and friends are more appropriate.

Although the outer delimiters can be set up using `\DeclareCiteCommand`'s optional `<wrapper>` argument for most styles, this is not possible for all styles. Similarly, inner delimiters can be set up with `\DeclareFieldFormat` in some styles, but other styles need more intricate implementations. This means that the commands discussed here can be used to place the citations between delimiters, but not natively to pass the result of a citation to a wrapper command as an argument.

Sets up the outer delimiters for the citation command `\<cite command>`. The name of the `<cite command>` is given without leading backslash in the argument, it normally corresponds to the delimiter context.

Note that outer citation delimiters are often hard-coded so they usually do not respond to delimiter context aliases. Inner citation delimiters, on the other hand, usually follow delimiter context aliases. This may lead to initially surprising results if aliases are used.

You may use almost any input for $\langle opening\ delimiter \rangle$ and $\langle closing\ delimiter \rangle$ as long as typesetting of $\langle opening\ delimiter \rangle\text{text}\langle closing\ delimiter \rangle$ does not lead to errors when arbitrary grouping such as $\{\langle opening\ delimiter \rangle\text{text}\langle closing\ delimiter \rangle$ or $\langle opening\ delimiter \rangle\text{text}\{\langle closing\ delimiter \rangle\}$ is introduced. It cannot be guaranteed that the opening and closing delimiters are executed at the same level of grouping, let alone in the same group. As mentioned above, citation delimiters cannot be used to introduce a wrapper command for the citation output, i.e. to pass the entire output of the citation command as argument to a macro.

Instead of hard-coded (,), [and] their biblatex counterparts `\bibopenparen`, `\bibcloseparen`, `\bibopenbracket` and `\bibclosebracket` are preferable, since these commands respond to nesting and check if opening brackets are always closed.

The styles of this bundle only use the values `outer` and `inner` for `⟨modifier⟩`, but other values are possible. With `outer` and `inner` you can use `\DeclareOuterCiteDelims` or `\DeclareInnerCiteDelims` and friends to define the opening and closing delimiters, otherwise you need to define them manually.

All styles of `biblatex-ext` define the wrapper commands listed in table 2.

5.4 Selected bibliography macros

The following macros are defined in `ext-standard.bbx` and may make certain things easier to customise. Many of these macros are replacements for bare `\printfield` or `\printlist` in the bibliography drivers, or pack a frequently-used sequence of commands into one central place.

barevolume+volumes A bibliography macro to print the volume, part and volumes fields for `@mvbook-`, `@book-` and `@inbook-` like entry types. If `maintitle` is defined, the volume and part fields will be printed by `maintitle+title` or `maintitle+booktitle` instead.

- version** Similar to the **edition** bibliography macro, **version** prints the version field, this avoids a direct `\printfield{version}` in the bibliography drivers.
- pagetotal** Similar to the **edition** bibliography macro, **pagetotal** prints the `pagetotal` field, this avoids a direct `\printfield{pagetotal}` in the bibliography drivers.
- in:editor(+others)** The bibliography macro to print the editor before the booktitle for `@inbook`, `@incollection` and `@inproceedings` when `innamebeforetitle` is set to true. The `\printname` uses the name format `ineditor`.
- language** A bibliography macro to print the language field, this avoids a direct `\printlist{language}` in the bibliography drivers.
- note** A bibliography macro to print the note field, this avoids a direct `\printfield{note}` in the bibliography drivers.
- pubinstorg+location+date** A general-purpose bibliography macro to catch `publisher+location+date`, `institution+location+date` and `organization+location+date`. This bibliography macro has one mandatory argument: the name of a list field, sensible values are `publisher`, `institution` and `organization`. By default the macro is defined and used as follows.

6 Tabular Bibliographies

An experimental addition to this bundle is the package `biblatex-ext-tabular` which allows you to typeset tabular (two-column) bibliographies. The package must be loaded after `biblatex` and has no further options.

If it turns out that the tabular bibliography package is useful on its own, it may be split off from the rest of this bundle in the future. In that case the name `biblatex-ext-tabular` may be deprecated in favour of something more snappy. The old name should then continue to work, but you may have to install a new package to be able to use it.

The package `biblatex-ext-tabular` can be used independently of the styles provided in this bundle. But no matter what style you use, you will probably have to apply some tweaks here and there to make the output look acceptable.

The code for the tabular bibliographies is based on Audrey's²³ answer to a question²⁴ on $\text{\TeX} - \text{\LaTeX}$ Stack Exchange. The code has been modernised to keep in sync with changes to internal macros and modified to allow for slightly more flexible setups, so any bugs you find are mine and not Audrey's. Please report them via the channels mentioned above in section 1.6.

Before tabular bibliographies can be used, a suitable definition must be supplied with `\defbibtabular`.

`\printbibtabular[<key=value, ...>]`

This command prints a tabular bibliography. It accepts the same options as `\printbibliography`, but note that `env` must be a tabular bibliography declared with `\defbibtabular`. The default value for `env` is `bibtabular`.

Note that there is no default definition for the `bibtabular` environment, so you must define it with `\defbibtabular` before use. An error will be issued if you fail to provide a definition for `bibtabular` before you use `\printbibtabular` with the default `env` value and no bibliography will be printed.



`\defbibtabular{<name>}{<begin code>}{<end code>}{<row code>}`

This command defines a tabular bibliography. The *<name>* is an identifier passed to the `env` option of `\printbibtabular` when selecting the environment. The *<begin code>* is \LaTeX code to be executed at the beginning of the environment, usually it will begin a tabular environment. The *<end code>* is executed at the end of the environment and would usually

end the tabular environment. The $\langle row\ code\rangle$ holds the code for one row in the tabular bibliography, it should have no more columns than ordered in $\langle begin\ code\rangle$ and should end with $\backslash\backslash$.

Please keep in mind that the tabular bibliography is subject to all limitations of the particular tabular environment you decide to use.



Within the $\langle row\ code\rangle$ argument the following macros are defined and can be used to typeset the result of bibliography macros. Each cell should normally be wrapped into exactly one of the following since they are responsible for providing the necessary entry data to the bibliography macros.

$\backslash plain\{\langle code\rangle\}$

Typesets $\langle code\rangle$ with the entry data of the current entry.

$\backslash plainlang\{\langle code\rangle\}$

Like $\backslash plain$, but typesets $\langle code\rangle$ in the language of the current item if the language switching options are enabled.

$\backslash anchor\{\langle code\rangle\}$

Like $\backslash plain$, but additionally sets a link anchor for the current entry. That link anchor is used when a citation links to the bibliography entry. There should only be one $\backslash anchor$ or $\backslash anchorlang$ per entry (and hence per row), and for proper linking there should be at least one. Usually $\backslash anchor$ or $\backslash anchorlang$ is the first cell in a row.

$\backslash anchorlang\{\langle code\rangle\}$

Like $\backslash anchor$, but in the entry language like $\backslash plainlang$.

$\backslash driver\{\langle precode\rangle\}$

Typesets the bibliography entry using the correct driver. This always uses the entry language if language switching is enabled. The $\langle precode\rangle$ argument can be used to execute code before the driver is executed. Usually $\backslash driver$ would be issued in the last (and widest) cell in a row, duplicate information can be cleaned up with help of the $\langle precode\rangle$ argument.

Recall that standard `tabular` can't break across pages, so you may want to give `longtable` a try. Additionally, the standard column specifiers `l`, `r` and `c` define flexible-sized columns which might not be appropriate here; `p` defines fixed-width columns but imposes justification, which does not look good if the columns are too narrow. You may want to look into fixed-width flush-left or flush-right columns²⁵.

The package also defines two helpful bibliography macros.

`tabular:sortname` Prints the labelname/sortname.

`tabular:omitsortname` Suppresses the labelname/sortname in the current group.

These two bibliography macros have a fairly basic definition that should make them compatible with most styles (not only bib_latex-ext or standard styles). Consequently, they may not be able to support all advanced features of the style you are using.

If you are missing anything, you will have to write versions of those macros that are tailored to the specific style you are loading and the features you want to use.



For the common case of two-column tabular bibliographies there is a thin wrapper around `\defbibtabular` that might turn out a bit easier to use.

This defines a two-column bibliography where the first column shows the primary name associated with the work (the labelname/sortname) and the second column shows the bibliography data with the primary name suppressed to avoid duplication. The anchor is set to the first column, so that a viewer jumps there if a link to the entry is followed.

7 Open Access Symbols

The package `biblatex-ext-oa` was inspired by a question²⁶ by pluton²⁷ on TeX.SX about promoting open access works by adding a small open access symbol into the margin.

The package must be loaded after `biblatex`. It is not tied to use with styles of this bundle, though it cannot be guaranteed that everything will work out of the box with all other styles. The package works as expected with the standard styles and should work with most contributed styles at least to some extent. For the actual typesetting of the symbol `biblatex-ext-oa` patches the bibliography macro `begentry` to include a call to the bibliography macro `oamark`.

The package may load the support packages `biblatex-ext-oa-doiapi`, `biblatex-ext-oasymb-pict2e`, `biblatex-ext-oasymb-l3draw` and `biblatex-ext-oasymb-tikz`. The preferred way to use those packages is to have them loaded automatically via `biblatex-ext-oa`'s package options. It should usually not be necessary to load any of these support packages directly with `\usepackage`, but it is possible to use them as stand-alone packages should the need arise in other situations.

Note that the macro `\oasymbol` must be defined and should contain an open access symbol that can be printed in the margin for the package `biblatex-ext-oa` to work properly. The package `biblatex-ext-oa` itself does not provide a definition for `\oasymbol` if the option `symbolpackage` is not used. So you should either set that option or define command `\oasymbol` yourself.



The package `biblatex-ext-oa` provides the following load-time options.

`enable=true, false`

default: true

This option controls whether the package is only loaded (`false`) or loaded and active (`true`). ‘Active’ means that the initial state of the global bibliography option `openaccess` is `auto` and that useful default settings are applied for semi-automatic open access detection. These useful defaults include patches of the bibmacro `begentry` and, if `doiapi` is enabled, also `doi+eprint+url`.

If the package is loaded with `enable` set to `false` the global bibliography option `openaccess` will be set to `false` and no sensible defaults are defined for the semi-automatic open access detection.

`symbolpackage=false, pict2e, l3draw, tikz`

default: false

Load one of the available open access symbol support packages.

`false` Don't load any symbol package.

Since `biblatex-ext-oa` does not provide a default definition for `\oasymbol`, you will have to make sure to define that command yourself if you don't load any of the symbol packages.



`pict2e` Load `biblatex-ext-oasymb-pict2e` to provide a definition for `\oasymbol` drawn in `pict2e`. See sections 7.3 and 7.3.1.

`l3draw` Load `biblatex-ext-oasymb-l3draw` to provide a definition for `\oasymbol` drawn in `l3draw`. See sections 7.3 and 7.3.3.

Please keep in mind that `l3draw` is still considered experimental.



`tikz` Load `biblatex-ext-oasymb-tikz` to provide a definition for `\oasymbol` that is drawn with PGF/TikZ. See sections 7.3 and 7.3.2.

The package `biblatex-ext-oasymb-tikz` will load PGF/TikZ.



`symbol=<symbol>`

Set `\oasymbol` to output the symbol identified as `<symbol>`. This option is passed on to the `<symbolpackage>` selected with the `symbolpackage` option. Possible values can be found in the respective subsections of section 7.3.

Note that this option is only available if the option `symbolpackage` has been set to a valid value different from `false` or one of the open access symbol packages has been loaded manually (the latter is usually not recommended, the option `symbolpackage` is the preferred way to load those packages).



`doiapi=true, false`

default: false

Whether or not to load the support package `biblatex-ext-oi-doiapi` that provides a Lua module to query open access information from Unpaywall²⁸ via the DOI of an entry.

The package `biblatex-ext-oi-doiapi` and thus this option can only be used with Lua^ATeX. With newer versions of the LuaTeX binary ($\geq 1.17.0$) you also need to enable the socket library via the command-line option `--socket`.

The following macros in `biblatex-ext-oa` are also of interest.

`\LoadOASymbolPackage[⟨symbol⟩]{⟨package⟩}`

This command provides an alternative to `symbolpackage` for loading a symbol package. The mandatory argument `⟨package⟩` can take the same values as the `symbolpackage` option. The optional argument `⟨symbol⟩` has the same meaning as the possible values for the `symbolpackage` option.

The command can only be used in the preamble. It may only be used once and only if none of the symbol packages have been loaded either explicitly or via the `symbolpackage` option. This command is related to `\DefineOASymbol` (see section 7.3).

`\oasymbol` This command holds the little symbol that is going to be printed in the margin to mark open access publications.

This command is initially undefined and must be defined for the package to work. One way of giving this command a useful definition is via the `symbolpackage` option of `biblatex-ext-oa`.

An entry will be marked as open access if it has a ‘best open access URL’. This best open access URL will be determined according to the rules set out by the `openaccess` bibliography option (see section 7.1) in the `\AtDataInput` hook, it is stored in the newly defined field `bestoaur`.

`bestoaur` field (literal)

This field holds the ‘best open access URL’ as determined by the open access detection outlined in section 7.1.

Note that this field need not hold the URL in expanded form.

Depending on the load-time options the package may define the following two bibliography macros.

`oamark` Prints the open access symbol if a best open access URL is available. This bibliography macro is available if the package is loaded with `enable` set to `true`

`api:bestoaur` Display the best open access URL according to the Unpaywall API. The URL is not shown if it coincides with the DOI, the check for that is performed by `\OpenaccessURLisDOI` (see section 7.2). This macro is only available if both the `enable` and the `doiapi` options are set to `true`.

This macro is useful in connection with the Unpaywall API since the best open access URL may not be amongst the fields that are already displayed in the entry.

With `enable` set to `true` the package will furthermore patch the bibliography macro `begentry` to execute the bibliography macro `oamark`. If additionally `doiapi` is true, the bibliography macro `doi+eprint+url` will be patched to include a call to `api:bestoaur`. Please keep that in mind should you need to redefine `begentry` or `doi+eprint+url`.



7.1 Open access detection

The heart of the package `biblatex-ext-oa` is the bibliography option `openaccess`, which can be set globally, per type or per entry.

A longer example document exploring various aspects of open access detection can be found at <https://github.com/moewew/biblatex-ext/blob/release/oaslinks.tex>.

`openaccess=auto, doiapi, forcedoiapi, true, false, none,` default: auto (none)
⟨open access field⟩

This option controls how the best open access URL is detected. The initial value is `auto` unless the package is loaded with the `enable` option set to `false` in which case the initial value changes to `none`.

All of the following values are valid at all three levels (global, per-type and per-entry), but not all options may be useful at all available levels.

- `auto` Use a semi-automatic heuristic to find the best open access URL.
- `all` Assume that all known ‘open access fields’ contain an open access URL.
Note that an entry still needs at least one field that open access field for the open access symbol to show up.
- `none` Assume that no known ‘open access field’ contains an open access URL.
The value `none` may be used to disable the `openaccess` feature.
- `doiapi` Use API queries from the `biblatex-ext-oa-doiapi` package to determine the best open access link from the DOI.

This option requires that the `doiapi` package option be set to `true` and only works with Lua \LaTeX . With newer versions of the Lua \TeX binary ($\geq 1.17.0$) you also need to enable the socket library via the command-line option `--socket`. Furthermore it needs a DOI in the `doi` field. If the `doi` field is empty, this option falls back to `auto`.



- `onlydoiapi` Like `doiapi`, but does not fall back to `auto` in case no DOI is present.
- `forcedoiapi` Like `doiapi`, but overrides more specific option levels that would say otherwise.

By default more specific options take precedence over more general options, that means that a per-entry option trumps a per-type option, which in turn overrides the global setting. If `forcedoiapi` is set it will prevail over more specific options that would say otherwise. A common use case is to override per-entry options with a global `forcedoiapi`.
- `forceonlydoiapi` A combination of `onlydoiapi` and `forcedoiapi`. This options overrides all more specific values and does not fall back to `auto` in case the DOI is not given.

- `true` An alias for `all`.
- `false` An alias for `none`.
- `<open access field>` Specifies that the open access version is given by `<open access field>`. This value would normally be used only on a per-entry level.
- Any field for which `\DeclareOpenAccessFieldUrl` has declared a URL specification is a valid ‘open access field’.

The heuristics to find the best open access link are governed by the following commands and rely on information present in the `.bib` file (ideally in field annotations).

`\DeclareOpenAccessFieldUrl[<openness>]{<field>}{<url spec>}`

Declares `<field>` to be an ‘open access field’. The code for `<url spec>` should expand to the full URL under which the entry can be accessed. The optional `<openness>` argument indicates whether the URL will always be open access (`always`) or whether it is only open access under certain conditions (`conditional`); if it is not present `conditional` is assumed.

If the package is loaded with `enable` set to `true`, the following declarations are active.

`\UndeclareOpenAccessFieldUrl{<field>}`

Disable `<field>` as ‘open access field’ and remove its mapping to a URL.

`\DeclareOpenAccessEprintUrl[<openness>]{<eprinttype>}{<url spec>}`

Declares the `eprinttype` `<eprinttype>` to be an ‘open access eprint type’. The code for `<url spec>` should expand to the full URL under which the entry can be accessed.

The optional `<openness>` argument indicates whether the URL will always be open access (`always`) or whether it is only open access under certain conditions (`conditional`); if it is not present `conditional` is assumed.

The `always` decision can be overridden on a per-entry basis by giving the field annotation `closedaccess`. If a field has `openness conditional` it is only considered for a particular entry if the field annotation `openaccess` is set.

If the package is loaded with `enable` set to `true`, the following declarations are active.

Since articles on the arXiv are always open access, the declaration for arxiv features the optional `<openness>` argument always.

Disable `<eprinttype>` as ‘open access eprint type’ and remove its mapping to a URL.

Define the priority order of ‘open access fields’ if several fields contain valid open access URLs. The fields processed in the given order and the last field prevails, meaning that fields later in the list have higher priority.

The default definition if the package is active is

which means that the DOI is given preference over eprints, which in turn prevail over the url field.

The auto detection works as follows.

- The best known open access URL is cleared.
- For each non-empty field listed in `\DeclareOpenAccessUrlFieldPriority` the URL specification is obtained.
 - If the field has `<openness>` `always`, the best known open access URL is updated with the new value, unless the field has been explicitly marked as closed access with the field annotation `closedaccess`.
 - If the field has `<openness>` `conditional`, the best known open access URL is updated with the new value if the field has been marked with the field annotation `openaccess`.

For auto-detection, an open access article with DOI would ideally use the field annotation `openaccess ({doi+an = {=openaccess}},)`.

If the `openaccess` option is set to one specific field only, only that field will be taken

into consideration and it will be assumed that the field contains an open access link unless the field annotation `closedaccess` is set. In particular the $\langle openess \rangle$ of each field does not play a role.

7.2 Open access detection with the Unpaywall API

Inspired by Eric Marsden's²⁹ answer to the open access symbol question on TeX.SX, the package `biblatex-ext-oa-doiapi`, which can be loaded via the `doiapi` option of `biblatex-ext-oa`, provides means to automatically find the best open access link to a given article via its DOI by querying the Unpaywall API³⁰.

This package can only be used with Lua \LaTeX . With newer versions of the Lua \TeX binary ($\geq 1.17.0$) you also need to enable the socket library via the command-line option `--socket`. The features of this package need online access to the Unpaywall API. Furthermore the Unpaywall API requires an email address and asks to limit requests to 100,000 calls per day^a.

To avoid too many calls to the API, the package caches its information in the temporary `.oai` file. It is safe to delete that file at any point, but if you do so the next Lua \LaTeX run may take a while, because all information has to be retrieved from the APIs. To avoid old information sticking around for too long you can set a cache expiration period.

`\SetDOIAPIMail{ $\langle email \rangle$ }`

Define the email address that is going to be used for API queries that require an email.

There is no predefined default email address. If the package is loaded and no email was provided until the beginning of the document (as tested in an `\AtEndPreamble` hook) you will receive a warning. A fatal error will be thrown if you try to query the Unpaywall database without an email address.



`\SetDOIAPICacheExpiration{ $\langle days \rangle$ }`

Set the expiration period for the cache. If the information for an entry in the cache is older than $\langle days \rangle$ days it will be queried again. The default expiration period is seven days.

`\IsOpenaccess{ $\langle DOI \rangle$ }{ $\langle true \rangle$ }{ $\langle false \rangle$ }`

Expands to $\langle true \rangle$ if the DOI is an open access work according to the Unpaywall database and to $\langle false \rangle$ otherwise.

`\GetOpenaccessURLWrapped{<DOI>}`

Obtain the best open access URL as returned by the Unpaywall API wrapped in the `\url` macro.

`\OpenaccessURLisDOI{<DOI>}{<true>}{<false>}`

Expands to `<true>` if the best open access URL as returned by the Unpaywall API is the DOI and to `<false>` otherwise.

7.3 Open access symbols

Currently, this bundle offers three methods of drawing the open access symbols. Each method is packed up in a little sub-package, end users are not expected to load these packages manually, instead they should use the option `symbolpackage` of `biblatex-ext-oa`.

The package `biblatex-ext-oasymb-pict2e` draws the symbols using `pict2e`'s picture environment. The package `biblatex-ext-oasymb-tikz` uses PGF/TikZ's `tikzpicture`. The package `biblatex-ext-oasymb-l3draw` finally uses L^AT_EX3's `l3draw` package. The main purpose of these packages is to define the macro `\oasymbol` for use with `biblatex-ext-oa`.

All packages define a similar set of macros, so they are not intended to be loaded together. If used as stand-alone packages, all packages only have one option.

`symbol=plos, oanet`

default: `plos`

This options determines which of the two available symbols is going to be used for `\oasymbol`.

The possible values are

`plos` Use the open access symbol by PLOS | Public Library of Science³¹ .

The drawing is based on a CC0³² work by PLoS (now PLOS | Public Library of Science), modified by Wikipedia users Nina, Beao, and JakobVoss³³.

`oanet` Use the open access symbol by open-access.net³⁴ .

The drawing is based on the logo uploaded to Wikimedia³⁵ and originally from open-access.net³⁶. Wikimedia claims the content does not meet the threshold of originality for copyright protection. Even if that is not the case, the legal notices on open-access.net³⁷ place all contents under a Creative Commons 4.0 Attribution International (CC BY 4.0) Licence³⁸ unless stated

otherwise. The logo designer is listed as *Medien + Design, Center für Digitale Systeme, Kompetenzzentrum e-Learning / Multimedia, Freie Universität Berlin*.

There is no implication that the open-access.net logo is not covered by the CC BY 4.0 terms. Indeed, the German ‘about us’ page explicitly states ‘Das Logo der Informationsplattform darf nachgenutzt werden, gerne mit einem Link zu open-access.net.’³⁹ The English version has ‘The logo of the information platform may be reused with a link to open-access.net’⁴⁰. While the German version leaves some leeway as to whether or not a link is required as attribution, the English version seems more explicit.

That means that if you do not follow Wikimedia in considering the symbol not protected by copyright in your – and all other relevant jurisdictions – due to its failure to cross the threshold of originality, you should probably treat it as CC BY 4.0 and treat the link to <https://open-access.net> as attribution requested by the Licensor according to Section 3(a)(1)(A) of the license. If you can’t reasonably meet the requirements of the license in your work, you may want to consider using the PLOS logo, which is licensed under CC0.

Apart from `\oasymbol` the packages only define one other user-level command.

`\DefineOASymbol[⟨symbol⟩]`

This command redefines `\oasymbol` to point to a different version of the symbol. The possible values for the `⟨symbol⟩` argument are the values of the `symbol` option.

7.3.1 Open access symbols with pict2e

The main purpose of the package `biblatex-ext-oasymb-pict2e` is to define the command `\oasymbol`. As mentioned above, usually this package is not going to be loaded as a stand-alone package, instead it is loaded via `biblatex-ext-oa`.

The package requires and loads the packages `pict2e`⁴¹ by Hubert Gäßlein, Rolf Niepraschk and Josef Tkadlec, `xcolor`⁴² by Uwe Kern and `xsavebox`⁴³ by Alexander Grahn.

If used as a stand-alone package, `biblatex-ext-oasymb-pict2e` has one load-time option, namely `symbol`, and defines one command besides `\oasymbol`, namely `\DefineOASymbol`. The option determines whether `\oasymbol` is defined to display the PLOS symbol (P) or the open-access.net symbol (OA). The command `\DefineOASymbol` can be used to change the definition of `\oasymbol` on the fly.

7.3.2 Open access symbols with TikZ

The main purpose of the package `biblatex-ext-oasymb-tikz` is to define the command `\oasymbol`. As mentioned above, usually this package is not going to be loaded as a stand-alone package, instead it is loaded via `biblatex-ext-oa`.

This package requires and loads the package `tikz`⁴⁴ by Till Tantau, its dependencies and `xsavebox`⁴⁵ by Alexander Grahn.

If used as a stand-alone package, `biblatex-ext-oasymb-tikz` has one load-time option, namely `symbol`, and defines one command besides `\oasymbol`, namely `\DefineOASymbol`. The option determines whether `\oasymbol` is defined to display the PLOS symbol () or the open-access.net symbol (). The command `\DefineOASymbol` can be used to change the definition of `\oasymbol` on the fly.

This package used to be called `biblatex-ext-oa-tikzsymbols`, for consistency reasons it has been renamed to `biblatex-ext-oasymb-tikz`.

The command `\DefineTikZOASymbol` has been renamed to the more generic `\DefineOASymbol`. Backwards compatibility code for that change is in place.

7.3.3 Open access symbols with l3draw

The main purpose of the package `biblatex-ext-oasymb-l3draw` is to define the command `\oasymbol`. As mentioned above, usually this package is not going to be loaded as a stand-alone package, instead it is loaded via `biblatex-ext-oa`.

This package requires and loads the full force of L^AT_EX3. Aside from the main package `expl3`⁴⁶ it loads `xparse`⁴⁷ and `l3keys2e`⁴⁸. Drawing is performed with the (still experimental) `l3draw`⁴⁹ package. The code works best with version 2021-02-18 or above of `l3draw`. The package also loads `xsavebox`⁵⁰ by Alexander Grahn.

If used as a stand-alone package, `biblatex-ext-oasymb-l3draw` has one load-time option, namely `symbol`, and defines one command besides `\oasymbol`, namely `\DefineOASymbol`. The option determines whether `\oasymbol` is defined to display the PLOS symbol () or the open-access.net symbol (). The command `\DefineOASymbol` can be used to change the definition of `\oasymbol` on the fly.
